All-time high on OMX's exchanges

- The number of share trades on OMX's exchanges reached an all-time high on May 18 amounting to 248,331 trades per day (Previous record: 205,955 trades on May 15, 2006).
- The value of average daily share trading amounted to EUR 5,029 million (Previous record: EUR 5,002 million, April, 2006).
- The average number of trades per business day amounted to 161,323 (Previous record: 128,031 trades per day, April, 2006).

Trading on OMX's exchanges

- The value of average daily share trading amounted to EUR 5,029 million (during the past 12-month period: EUR 3,650 million).
- The average number of trades per business day amounted to 161,323 (during the past 12-month period: 104,704).
- The average daily trading volume in Swedish, Finnish and Danish equity and fixed-income derivative products amounted to 623,612 contracts (during the past 12-month period: 541,339).

Trading on the Stockholm Stock Exchange – All time high

- The value of average daily share trading amounted to EUR 3,137 million (Previous record: EUR 3,013 million, April, 2006).
- The average number of trades per business day amounted to 95,008 (Previous record: 71,726 trades per day, April, 2006).

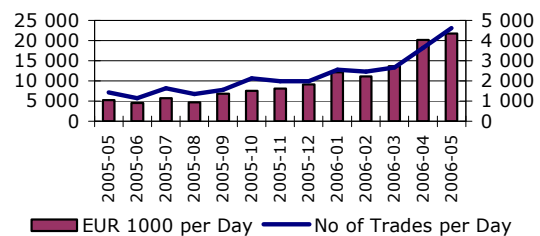
Derivatives trading



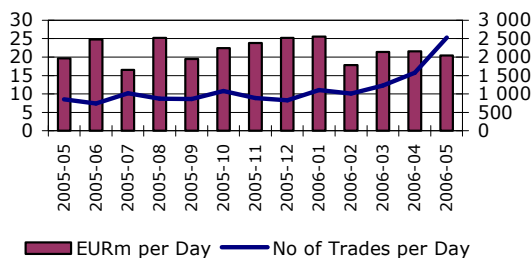
Total Bond trading
