EXPLANATORY NOTE***Group structure and changes on it***

In interim report for 9M 2004 the financial indicators of AS Harju Elekter (the consolidating entity) and its subsidiaries are consolidated line-by-line and the results of affiliated companies by the equity method. The shares of PKC Group Oyj are recognised on the balance sheet on the fair value basis. As of 30.09.2004, Harju Elekter owns significant holdings in the following commercial undertakings:

Harju Elekter purchased 51% of the shares of the Lithuanian company UAB Rifas in October 2003. Thus the compared period of the report – 9M of 2003 – does not contain the economic indicators of Rifas.

Introduction

Economic climate improved in almost all economic areas, including Western Europe, which is of considerable importance to Estonia. Finland and Sweden, Estonia's main trading partners, are also doing better this year than in 2003 and it is hoped that they see a 3% economic growth. Latvia and Lithuania are developing very well with expectations for economic growth of even 8%; the relevant figure for Estonia is 6%. According to estimates, inflation will remain at the level of 3,5%. It is imperative that during the following six months forecasts indicate continuous development of the domestic market as well as foreign trade.

The economic results of the consolidation group for the 9M were generally good and met our expectations. The number of sales orders in the Q3 considerably exceeded the volume of the Q2 as well as in Estonian market also in Finnish and Lithuanian markets. Compared to the same period last year, the sales increasing by 33,9% and operating profit by 70,4%, gross margin improved up to 7,6%.

Important events

The annual general meeting of shareholders was held on 16 April, and 106 shareholders or their authorised representatives participated, who represent 62,7 % of the total number of votes. The general meeting decided to pay dividends to the owners at the rate of EEK 4,00 (EUR 0,26) per share. Dividends paid to the shareholders on the week 20.

AS Keila Kaabel, associated company of Harju Elekter, opens its new production hall on 4th of May. The expansion project comprised the construction of a new production hall with an area of 2 500 m² and the reconstruction of the production lines. The new technology and the extended production facility will enable the Keila Kaabel factory to improve productivity and broaden its product range and quality.

According to a long-term lease contract, Keila Kaabel leases 7 600 m² of the production space and an external storage of more than 10 000 m² from the registered immovable belonging to Harju Elekter.

For a better servicing of its customers in East Estonia and enlarging its market share in the area, Harju Elekter opens its fourth store of electrical materials and equipment in Jõhvi on 3rd of June.

On the 17th of June UAB Rifas, the Lithuanian subsidiary of Harju Elekter, opened a new production building in Panevežys. Newly-built production area has 1300 sq. m of floor space that allows for doubling of the plant's production volumes and expanding the product range from manufacturing automation products to energy distribution and construction products. The necessary know-how for entering the new market segment and a large number of components and semi-finished products is supplied from Estonia. The investment in the construction and technical equipment totaled MEEK 8 (MEUR 0,5) and it was financed from own funds.

On the 4th of September AS Harju Elekter and PKC Eesti concluded preliminary leasehold contracts for long-term lease of additional production space. At the request of PKC Group, AS Harju Elekter will expand the production space of its Estonian subsidiary by 8400 m². 5400 m² of that production space will be at the disposal of the PKC Eesti Keila factory and 3200 m² at the disposal of the Haapsalu factory. PKC Group needs the additional production space due to the increase in the volume of orders and the transfer of the production operations previously performed in the Netherlands and Finland, to Estonia. The new halls will be completed in May 2005.

In relation to placing, shares could be subscribed for from 16.09 to 30.09.2004. Those who had concluded share subscription contracts could participate in the subscription. During the period, all the 200 000 registered ordinary shares issued with a nominal value of EEK 10 were subscribed for. Payment for the shares issued took place simultaneously with the subscription period and all the shares subscribed for have been duly paid for.

PKC Group Oyj's Extraordinary General Meeting held on 20.09.2004 accepted Management Board proposal to pay extra dividend for 2003 in the amount of 0.5 EUR per share and organise the bonus issue. Dividends paid to the shareholders in 30th of September. The list of shareholders with the right to bonus issue was compiled on 23rd of September. During the bonus issue, 11 640 348 new shares will be distributed so that two new shares will be given for each old share. New shares give the right to dividends for the financial year of 2004. After the bonus issue, the number of PKC shares will be 17 460 522. The list of shareholders participating in the bonus issue will be compiled on 23.09.2004. Harju Elekter is the largest shareholder of PKC who, after the bonus issue, will own 1 860 003 PKC shares or have a holding of 10.65%.

Revenues, expenses and profit

The sales revenue of the consolidation group AS Harju Elekter comprised MEEK 315, 2 (MEUR 20,1) in the 9M 2004, increasing by 33,9% in comparison with the same period of the previous year. Of the sales revenue, 77,6% accounted for the sales of industrial products and 14,5% for intermediate sales and sales of services. At the same time, the sales of products in the 9M increased by 32,7% in comparison with the same period in 2003, and the sales of services and intermediate sales altogether increased by 38,5%. Q3 was successful for all the companies of the group. The sales of the Q3 of 2004 exceeded the sales of the Q2 by 21,1%

Of the sales revenue of the consolidation group AS Harju Elekter, 47,7% is ascribed to the sales to Estonia and 52,3% to the sales to foreign markets.incl.38,5% to Finland and 11,4% to Lithuania. The sales to the Estonian market went up by 21,3%. The sales of products to foreign markets went up by 48,0%. Attention should be paid to the fact that the data of the 9M 2004 include also the consolidated sales revenues of the Lithuanian subsidiary Rifas in amount 36,1 MEEK (2,3 MEUR).

The total profit of the consolidation group AS Harju Elekter was MEEK 59,3 (MEUR 3,8), being 34,8% higher than in the previous year. The return of profit in the Group was 18,8% (9M 2003: 18,7%), in Q3 20,8% which was even 2 % points better compared to the same period in last year.

The general administrative expenses were MEEK 21,1 (MEUR 1,3) and the marketing expenses MEEK 14,4 (MEUR 0,9), growing both together in amount 5,8 MEEK (373 TEUR). The indicators of 2004 also include the expenses of the Lithuanian subsidiary Rifas in amount 4,7 MEEK (298 TEUR). The comparable growth is thus MEEK 1,1 (TEUR 70), i.e. 3,7 % that is clearly slower than the growth of sales.

Depreciation of the fixed assets of the consolidation group in the 9M 2004 was MEEK 9,3 (TEUR 595) or 36,0% more than in the same period of the previous year. Depreciation of fixed assets in amount MEEK 1,1 (TEUR 72) is calculated by UAB Rifas and gave 45% of the total increase of depreciation. The rapid growth in depreciation was triggered by the investments made in 2003 in expanding the rental and production premises and enhancing the capacities.

The total operating profit of the consolidation group AS Harju Elekter was MEEK 24,0 (MEUR 1,5), being 70,3% higher than in the previous year. As the growth rate of sales significantly exceeded that of fixed costs, the profit margin of the group for 9M was higher than that of 2003 by 1,6 percentage points, reaching 7,6%, and 11,2% in the Q3 (Q3 2003: 7,3%). In the parent company, the turnover grew by 17,7%, the total profit by 23,3% and the operating profit by 37,1%.

Financial operations yielded a total profit of MEEK 73,1 or MEUR 4,7 (9M 2003: MEEK 96,8 or MEUR 6,2). The market price of a PKC Group Oyj share changed only little in the Q3, decreasing by 7 euro cents (EEK 1,10); in the Q3 of 2003, however, the market price of the share increased by 99 euro cents (EEK 15,49), resulting in additional financial income in the amount of MEEK 29,0 (MEUR 5,2). A total of MEEK 48,8 or MEUR 3,1 (9M 2003: MEEK 81,3 or MEUR 5,2) of financial income was received from the revaluation of shares in the 9M of 2004. PKC Group Oyj paid dividends for 2003 in the total amount of MEEK 24,3 or MEUR 1,5, which is exceeds the relevant figure for last year by more than five times.

The net profit of the consolidation group was MEEK 94,8 or MEUR 6,1 in the 9M 2004 (9M 2003: MEEK 110,8 or MEUR 7,1) EPS was 17,49 kroons or 1,12 euros (9M 2003: 20,52 kroons or 1,31 euros).

Investments and capital employed

During the accounting period, the Group invested in tangible and intangible assets a total of MEEK 24,5 or MEUR 1,6 (9M 2003: MEEK 38,9 or MEUR 2,4), of which in technology was MEEK 12,6 or MEUR 0,8 (9M 2003: MEEK 2,7 or TEUR 170) and construction and renovation work of buildings and plant was MEEK 13,0 or MEUR 0,8 (9M 2003: MEEK 31,8 or MEUR 2,0).

Employees

The average number of employees in the Group in 9M 2004 was 372 (9M 2003: 286), including 195 (9M 2003: 174) employees in the parent company. As of the balance sheet date 30 September 2004, the

number of employees in the Group was 383 (9M 2003: 294). A significant change in the number of employees was caused by the purchase of the Lithuanian subsidiary Rifas (+68 people) in Q4 2003.

NOTES TO INTERIM FINANCIAL STATEMENTS

Note 1. Accounting methods and valuation principles used in the consolidated interim report

AS Harju Elekter is a company registered in Estonia. The consolidated annual accounts prepared as of 30.09.2004 include AS Harju Elekter and its subsidiaries AS Eltek, Satmatic Oy and Rifas UAB (together referred to as "Group"). AS Harju Elekter has been listed on Tallinn Stock Exchange since September 30, 1997, 30 % of the shares are held by AS Harju KEK.

This consolidated interim report is prepared in accordance with the Accounting Act of the Republic of Estonia applicable as from 1 January 2003, "Guidelines for Preparation and Submission of Interim Reports" issued by the Accounting Standards Board, and the requirements for international accounting standard IAS 34 "Interim Financial Reporting" on condensed interim financial statements. The interim report is prepared on the basis of the same accounting methods as used in the annual report concerning the period ending on 31.12.2003.

According to the assessment of the management board, the interim report of the 9M 2004 of AS Harju Elekter presents a true and fair view of the financial result of the consolidation group guided by the going-concern assumption. This interim report has been neither audited nor monitored by auditors by any other way and only includes the consolidated reports of the group.

The financial statements of AS Harju Elekter are presented in thousands of Estonian kroons and euros. The EEK/EUR exchange rate is 15,64664 according to the quotation of Estonian Bank.

MEEK 8 (TEUR 511) was received for the shares to equity capital, of which MEEK 6 (TEUR 383) was issue premium. The management board of the company confirmed the results of subscription as of 30 September 2004 by its resolution adopted on 4 October 2004.

After the issue, the share capital of Harju Elekter is MEEK 56, divided into 5,6 million ordinary shares.

Based to the good results of 2003 the annual general meeting of shareholders was decided to pay dividends to the owners at the rate of EEK 4,00 (EUR 0,26) per share, totally in amount MEEK 21,6 (MEUR 1,38) without obligation to paying taxes. Dividends paid to the shareholders in 12th of May 2004.

Note 5 Segmental reporting

Pursuant to the established internal accounting and reporting procedure, the primary form of accounting in the Group is by business segments and the secondary by geographic areas. The business activities of the Group have been classified by business segments, based on the characteristics of the products and services as well as of the consumers of these products and services.

Business segments

The Group operates in two business segments:

“electrical engineering” – designing, production and marketing of power distribution and control systems, subcontracting for energy, construction and production sectors, intermediary trade in electrical equipment.

“telecommunications” – manufacturing and marketing of various type of sheet metal and fiber-optic products for data networks for the telecommunications sector, installation of computer, communication and alarm networks, provision of communication services and intermediary trade in communication systems.

In the results of 9M 2004 contains the consolidated net sales of Rifas. The addition of the Lithuanian segment increased the nine-month sales of the group by a total of 14,7% compared to the same period of last year, including 13,6% in terms of electrical equipment and 28,9% in terms of trade and intermediate sale. This also explains the excessive growth in the sales volume on the Lithuanian market. The Lithuanian subsidiary was acquired in October 2003.

The EGM of shareholder gave on 20th of September its approval to the proposal of the management board to organise bonus issue. The list of shareholders participating in the bonus issue will be compiled on 23.09.2004. During the bonus issue, 11 640 348 new shares will be distributed so that two new shares will be given for each old share. New shares give the right to dividends for the financial year of 2004. After the bonus issue, the number of PKC shares will be 17 460 522. Harju Elekter is the largest shareholder of PKC who, after the bonus issue, will own 1 860 003 PKC shares or have a holding of 10.65%.

As of the end of the quarter on 30 September 2004, the financial investment was revalue at the closing price of the last trading day that is 8,76 EUR (137,06 EEK). The revaluation generated financial expenses in the amount of 2,1 MEEK (0,14 MEUR)

Note 9 Basic and diluted earnings per share

Ordinary net profit per share is calculated by dividing the net profit earned during the reporting period by the average weighted number of issued shares.

Diluted net profit per share is calculated by dividing the net profit by the average number of shares of the period, considering also the number of potential options. In relation to placing in equity option, shares could be subscribed for from 16.09 to 30.09.2004. Those who had concluded share subscription contracts could participate in the subscription. During the period, all the 200 000 registered ordinary shares issued with a nominal value of EEK 10 were subscribed for. Payment for the shares issued took place simultaneously with the subscription period and all the shares subscribed for have been duly paid for. As of 30 September 2004, the parent company has no potential shares. Thus, the diluted net income per share equals net income per share.

TEUR 200 (MEEK 3,1) of the loan granted to the subsidiary Satmatic OY was allocated for the increase of the subsidiary's share capital. By the end of the H1 Satmatic returned to the parent company the full long-term loan in the amount of MEEK 2,07 (TEUR 133). In the second quarter Harju Elekter gave to Satmatic OY a short-term loan in the amount of TEUR 200 (MEEK 3,1), which was returned by the end of the quarter. Loan interest was 5%.

The parent company rented to Eltek a truck on terms of financial lease with the acquisition cost of TEEK 274 (TEUR 17,5) and interest 5,5%. During 9 months Eltek paid financial lease payments to the parent company in the total amount of TEEK 76,3 (TEUR 4,9).

During 9M a total of TEEK 68,4 (TEUR 4,4) of interest income from subsidiaries was entered to the financial revenues of the income statement of the parent company.


